

TERMS AND CONDITIONS

Definitions

'Client' shall mean the party ordering services from Dieudonne Editorial Services.

'Enquiry Form' shall mean the enquiry form completed by the Client on the Dieudonne Editorial Services website or by email/post.

'Services' shall mean the services specified on the Dieudonne Editorial Services website or otherwise agreed in negotiation with Dieudonne Editorial Services.

'Order' shall mean the order confirmation that the Client will be sent once the Enquiry Form has been completed and Dieudonne Editorial Services has confirmed the details of what Dieudonne Editorial Services has agreed to supply to the Client in accordance with these terms and conditions and other various policies to be found on this website.

'Copy', 'Document' and 'Manuscript' refers to the text that the Client requires Dieudonne Editorial Services to provide their services for/on. There is no implied or intended difference between these descriptions.

'Party' or 'Parties' Dieudonne Editorial Services and the Client.

Introduction

All contracts made by Dieudonne Editorial Services for the supply of editorial Services are subject to and governed by these terms and conditions which may only be varied by Dieudonne Editorial Services in writing. No binding contract shall be deemed to have come into existence unless and until accepted in writing by Dieudonne Editorial Services by email or otherwise and shall be at the price stated on this acceptance. The Client will not assign its rights or obligations under these terms and conditions without the prior written consent of Dieudonne Editorial Services. The Contract created by these terms and conditions is between Dieudonne Editorial Services and the Client and does not to confer any rights of any nature upon any party other then the Client and Dieudonne Editorial Services.

Dieudonne Editorial Services may terminate the Contract immediately by notice through email in the event of the Client's failure to make the due payments under the Contract or the Client being in breach of any of these terms and conditions. In the event of Dieudonne Editorial Services terminating the Contract, the Client shall immediately pay to Dieudonne Editorial Services all sums due under the Contract without rebate or allowance.

The Client assumes all responsibility for any liability resulting from the falsification or misstatement of personal information. Dieudonne Editorial Services reserves the right to refuse service to anyone whom it believes to have falsified personal details.

If a separately agreed arrangement is negotiation and entered into with Dieudonne Editorial Services, the terms of such written agreement are in addition to these online terms and conditions and, to the extent of any inconsistency between these online terms and such written agreement, the written agreement shall take precedence. These online terms, and the terms of any written agreement, coupled with the privacy policy and all other policies shown on the 'Small Print' page of the Dieudonne Editorial Services website, make up the overall agreement between Dieudonne Editorial Services and its Clients.

The contract between the Client and Dieudonne Editorial Services commences as soon as payment is received. Furthermore, receipt of payment confirms the Client's intention to initiate

the service process. If a Client wishes to cancel any services provided by Dieudonne Editorial Services subsequent to payment, then they must contact us and a refund will be issued (minus any costs incurred through administration and service delivery) as per the cancellation schedule shown on the relevant policy on the website. Dieudonne Editorial Services reserves the right to cancel any contract at its discretion for any reason without explanation.

Services

Clients are welcome to provide notes and/or style guides in order to achieve certain specific criteria that the Client wishes to follow, which will be subject to agreement by Dieudonne Editorial Services. All dates and times provided for the delivery of the content are approximate and based on previous orders of similar specifications. Dieudonne Editorial Services cannot be held liable for any loss or damage caused by a later delivery time than has been quoted.

If the Client does not provide accurate contact information, or if they do not respond promptly if further information is required by Dieudonne Editorial Services, then Dieudonne Editorial Services cannot be held responsible for delays in providing the service. Dieudonne Editorial Services strives to meet exact deadlines and prides itself on the prompt service provided. However, Dieudonne Editorial Services is not liable for any result from a delay in the service. In such an instance where a delay may be unavoidable, Dieudonne Editorial Services will make commercially reasonable efforts to contact the Client and remedy the situation.

Payments

All prices are quoted in Great British Pounds (GBP) and payments must be made in that currency. All Clients are required to pay for services prior to any work commencing. Payment must be in full unless otherwise agreed in writing by Dieudonne Editorial Services. Dieudonne Editorial Services may, at its sole discretion, offer monthly invoicing arrangements to regular business Clients and personal Clients and may agree to additional or modified terms for such arrangements. Unless otherwise agreed to in writing, payment is due when the invoice is rendered. Where Dieudonne Editorial Services has agreed that the Client may pay by instalments, the Client is obliged to make the payments on the due dates. In the event that the Client fails to pay the full amount due on the due dates, the Client shall pay interest on the amount unpaid at the rate of four percent (1%) per month or part thereof. Dieudonne Editorial Services shall be entitled to suspend the carrying out of services until such payment is made without any liability to the Client for non-performance or otherwise.

Any claims of whatsoever nature by the Client against Dieudonne Editorial Services in respect of the services rendered shall not entitle the Client to withhold payment for any part of said services or other service purchased by the Client from Dieudonne Editorial Services. The Client agrees to be bound by Dieudonne Editorial Services' refund policy. Refunds will only be given in extreme circumstances – at the complete discretion of Dieudonne Editorial Services. The Client shall indemnify and keep Dieudonne Editorial Services indemnified against all liability in respect of any infringement of copyright or any other similar right or claim resulting from a breach of this condition. If Manx law does not cover the specific area, and only then, English Law may be considered. Any legal action against Dieudonne Editorial Services

shall take place in the courts of the Isle of Man. If any provision of this agreement shall be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this agreement and shall not affect the validity and enforceability of any remaining provisions.

Plagiarism
